Enclosed is an Appendix 3B in respect of the shares issued to shareholders pursuant to the McPherson's Limited Share Purchase Plan.

As previously announced on 10 September 2009 and contemplated under the Share Purchase Plan, McPherson's has scaled back applications under the Share Purchase Plan so that the total amount of additional capital raised does not exceed \$3 million.

Applicants will be allocated shares for approximately 43.4% of the amount subscribed, except that shareholders who held over 50,000 shares at the record date or who subscribed for \$1,000 of shares were not subject to a scale back, and subscriptions for \$2,000 of shares have been scaled back by 45%.

The new McPherson's shares will be allotted today, Thursday, 17 September 2009, and the statements of holdings for these new shares will be despatched to shareholders on Wednesday, 23 September 2009.
